DISTRIBUTION AND SHIPPING FEES

<u>Tank Prep, Transfer, Handling</u>		
Vapor Shipper Rental	\$210	This covers a single shipper containing up to 20 doses of frozen semen from any number of stallions, frozen embryos, or stem cells, all preparation, handling, and transfer, and up to 10 day rental of the shipping container.
Client-Owned Tank	\$120	This covers nitrogen charging of a client-owned tank, and up to 20 doses of frozen semen from any number of stallions, frozen embryos, or stem cells, all preparation, handling, and transfer of items to tank.
<u>Shipping Charges</u>		
Next-Day Priority FedEx	\$425	FedEx Next-Day Priority Overnight of tank to recipient, tank return included.
2-Day Delivery	\$365	FedEx 2nd-Day delivery of tank to recipient, tank return included. Please Note: 2nd-Day option not available on Thursday/Friday unless Saturday Delivery is requested. Subject to available tanks during peak season.
FedEx Ground.....	\$200	FedEx Ground delivery of tank to recipient, tank return included. Please Note: Ground option not available during peak season outside of Florida.
Courier	\$TBD	When available, couriers can be used to transport in Florida. Pricing varies by destination.
International Priority (Canada)	\$1,085* (estimate)	This includes FedEx International Priority (1-3 Days), USDA Health Endorsements, Certificates, customs processing, tank return included. *USDA Fees subject to change
Canadian shipments require an import permit from the receiving facility to be sent to WellGrove before shipping. Any duties owed will be billed directly to the importer.		

ASSOCIATED DISTRIBUTION FEES

Saturday Delivery	\$30	Covers additional FedEx charges for Saturday Delivery
Rush Fee	\$120	Shipment request forms MUST be received by 12pm EST to ensure shipment the same day. When a request is submitted late we will try our hardest to accommodate you IF at all possible, however a rush fee will apply.
Container Late Fee	\$30	WellGrove allows the client or agent/clinic to keep the shipping container for up to 4 days. If the container is not confirmed as being in transit by the transport company (such as FedEx, UPS, etc.) within four (4) days following the initial delivery date, client will be charged a daily late fee of \$30.00 per day until the container is returned.
Container Replacement Fee	\$2100	If a tank is not returned within 15 days of receiving and/or other arrangements have not been discussed, WellGrove will charge this fee for the full replacement of the tank. When/if the tank is finally returned, this fee will be refunded, less any late fees.
